**PRISON AUTHORITIES CONSTANTLY MONITOR, BLOCK, AND  
CONFISCATE PRISONERS' LETTERS & CALLS, AND PUBLICATIONS.**

**THROUGHOUT UMER'S TIME IN PRISON HE HAS ONLY RECIEVED A VERY  
SMALL AMOUNT OF HIS MAIL, AND SOME OF THE LETTERS THEY HAVE  
BEEN HOLDING INCLUDE LEGAL CORRESPONDENCE, DIRECTLY  
IMPACTING THE PROGRESS OF HIS CASE ALONGSIDE BLOCKING LEGAL  
VISITS.**

**HE WAS DENIED ACCESS TO AN ARABIC QURAN FOR THE FIRST MONTH,  
AND HE WAS ALSO PREVENTED FROM ATTENDING JUMMAH PRAYERS.  
HE WAS NOT ALLOWED ACCESS OR CONTACT WITH THE IMAM FOR  
RELIGIOUS COUNSEL.**

**HE WAS INITIALLY ONLY GRANTED 2 VISITS A MONTH. THIS HAS  
INCREASED, BUT IT IS STILL ONLY 2 VISITS A WEEK, REMAND  
PRISONERS HAVE A RIGHT TO 3.**

**THROUGHOUT UMER'S TIME IN PRISON HE HAS ONLY RECIEVED A VERY

**COUNTER-TERROR LAWS ARE BEING USED TO TARGET THOSE ENGAGED IN PROTEST AND/OR DIRECT ACTION, WITH MISUSE OF THE 'PREVENT' STRATEGY.**

**WE HAVE SEEN MULTIPLE INDICATORS OF CORRUPTION DURING THE PROCESS OF PROSCRIPTION, AND THE JUDICIAL REVIEW, INCLUDING CHANGING THE PANEL OF JUDGES MID-WAY THROUGH THE REVIEW TO THOSE WITH LINKS TO THE STATE OF ISRAEL. WHEN ASKED WHY JUDGE CHAMBERLAIN, WHO GRANTED THE JUDICIAL REVIEW, HAD BEEN REMOVED FROM THE CASE, THE MINISTRY OF JUSTICE REDIRECTED ENQUIRIES TO THE JUDICIARY PRESS OFFICE, WHICH REFUSED TO COMMENT.**
